

# Privacy declaration for training participants at Advanced Nuclear Fuels GmbH (ANF GmbH)

---

With the following information, we would like to give you an overview of the processing of your personal data by us and your resulting rights, especially when using the management system for instructions and training (SAM - EHS system) the company SECOVA. Which data is processed in detail and in which way your data is used depends largely on the respective requested or agreed trainings. Therefore, not all statements contained herein may apply to you.

Before entering the premises and the buildings of the ANF, all persons (for example, employees of external companies, visitors, employees with a factory contract, interns...) must receive a legally required training and instruction depending on the type of activity on the premises (for example, fire protection, first aid, electrical hazards, ANF safety standards). For this purpose, the collection and processing of your personal data is necessary.

## 3. Type of personal data collected

---

We process the following personal data that we receive from you as part of our business relationship:

- Surname and first name
- Company data
- Address data
- Telephone
- E-Mail
- Bank details

## 4. Processing purposes and legal basis

---

ANF GmbH collects your data,

- to check the eligibility requirements,
- to be able to organize and carry out the respective training,
- to be able to issue participation/examination certificates and duplicate documents for you,
- for the implementation of audits/training;
- for sending ANF-relevant information (flyer, newsletter)
- for the settlement of the participation fee for events with invoices for transfer.
- to create and maintain a list of participants with personal contacts,
- to communicate information on participation in ANF training courses,
- for the creation of participant name badges and personal certificates,
- to be able to carry out a statistical evaluation and preparation of the events. These are done to increase the efficiency of the offered products.

## 4.1 In the context of the performance of a contract (Article 6.1 letter b GDPR)

The collection and processing of your personal data is necessary for the execution of a contract or pre-contractual measures as well as for the fulfillment of legal obligations.

## 4.2 In the context of the balancing of interests (Art 6 par 1 letter f GDPR)

ANF GmbH has a legitimate interest in carrying out audits, training courses and their ongoing optimization. Furthermore, there is a legitimate interest in the optimization of our services through scientific research and for advertising purposes.

## 5. Recipients of your data

---

### 5.1 Within our company

Your data will remain with ANF GmbH. Internal receiver is the training center. In exceptional cases, the company's data protection officer can be granted access to your data as an external body.

### 5.2 In the context of contractual processing

Your data may be passed on to service providers who work for us as contract processors for the:

- Support or maintenance of IT systems and applications
- Use of the SAM training system
- Organization and implementation of trainings
- Commercial handling of the trainings (booking, billing)
- Preparation and dispatch of participation confirmations, certificates etc.

All service providers are contractually bound and obliged to treat your data confidentially.

### 5.3 Other third parties

Data will only be passed on to recipients outside of our company in compliance with the applicable data protection regulations. Recipients of personal data may include:

- Public bodies and institutions (such as financial or law enforcement authorities) in the event of a legal or regulatory obligation.

### 5.4 Transfer of data to a third party country

Your personal data will not be transferred to a third party country.

## 6. Duration of storage of your data

---

The data deletion takes place under consideration of the legal retention periods.

The exception is the consent of the participants to the further use of the data for the reception of e-mail newsletters. In this case, the data will be deleted with revocation of the consent in compliance with the statutory retention periods. Participant data will be deleted at the latest six months after the event if the legal retention periods do not apply.

## 7. Your data protection rights

---

You have the right to information pursuant to Article 15 GDPR, the right to rectification pursuant to Article 16 GDPR, the right to erasure pursuant to Article 17 GDPR, the right to restrict processing pursuant to Article 18 GDPR and the right to data portability pursuant to Article 20 GDPR.

In accordance with this provision, you also have the right to object to the processing of your data under Article 21 GDPR. Please address such concerns to

The right to information and the right to erasure may be subject to restrictions pursuant to section 34 and section 35 of the German Federal Data Protection Act.

## 8. Your right for a complaint with a supervisory authority

---

You can at any time lodge a complaint with the respective data protection supervisory authority, for example at your place of residence, your workplace or at the place of the alleged violation, in accordance with Art. 77 GDPR.
